- (1) If graduated on or after January 1, 2007, possesses a doctorate degree in audiology from a program accredited, at the time of the applicant's graduation, by the educational standards board of the American Speech-Language-Hearing Association or its successor organization, the Accreditation Commission for Audiology Education, or other accreditation organization recognized by the United States Department of Education to accredit audiology education programs,
- (3) (A) has completed an integrated educational program which, at the time of the applicant's completion, satisfied the educational requirements of the American Speech-Language-Hearing Association for the award of a certificate of clinical competence; and
- **(B)** has satisfactorily completed a minimum of thirty-six weeks, including at least one thousand eighty hours of full-time or a minimum of forty-eight weeks, including at least one thousand four hundred forty hours of part-time professional employment in audiology under the supervision of a licensed audiologist. Such employment shall follow the completion of the educational requirements and shall consist of at least six sessions of supervision per month providing a total of at least four hours of supervision per month, at least two sessions of which shall provide a total of at least two hours of direct on-site observation of audiology services provided by the applicant. For purposes of this section, "full-time employment" means a minimum of thirty hours a week and "part-time employment" means a minimum of fifteen hours a week. Persons engaged in such employment under the direct supervision of a person holding a valid hearing instrument specialist's license or a license as an audiologist, who is authorized to fit and sell hearing aids pursuant to section 20-398 shall not be required to obtain a temporary permit pursuant to section 20-400.
- **(b)** The postgraduate supervised employment requirements of subsection (a) of this section shall be waived for persons who have been awarded a doctoral degree in audiology from an accredited program on or after January 1, 2007.
- **(c)** The commissioner may waive the written examination required in subsection (a) of this section for any person who:
 - (1) Is licensed as an audiologist in another state or territory of the United States and such state has licensing requirements at least equivalent to the requirements in this state; or

In order to be considered for licensure as an audiologist on or after January 1, 2007, the applicant must satisfy the following requirements:

- (a) For Doctoral Degree applicants.
- (1) Education Requirements. Applicants whose degree was earned on or after January 1, 2007 must have earned a doctoral degree program with a major emphasis in audiology that addresses the knowledge and skills pertinent to the profession of audiology, from an institution of higher learning that is, or at the time the applicant was enrolled and graduated was, accredited by an accrediting agency recognized by the United States Department of Education or its successor organization.
- (2) Clinical Practicum Requirements. Applicants must submit certified evidence of completion of post-baccalaureate directly supervised clinical practicum with cases representative of a wide spectrum of ages and communicative disorders within the first three years of doctoral degree program.
- (3) Applicants must complete and provide documentation of one of the following:
- (i) Certified evidence of having obtained required professional experience that is equivalent to a minimum of 12 months of full-time supervised clinical practicum. The required professional experience must be approved by an academic program. The students must obtain a variety of clinical practicum experiences in different work settings and with different populations so that the applicant can demonstrate skills across the scope of practice of audiology. Acceptable required professional experience includes clinical and administrative activities directly related to patient care. A calendar week of clinical practicum is defined as a minimum of 35 hours per calendar week in direct patient/client contact, consultation, record keeping, and administrative duties relevant to audiology service delivery. The required professional experience must be obtained with an accredited program or one of its cooperating programs or, (ii) A paid clinical experience that meets the requirements of Rule 609-3-.04(a) 1, for Masters Degree audiology licensure candidates.

To be eligible for licensure by the board as a speech pathologist or audiologist, a person shall:

- (1) Possess at least a master's degree or its equivalent in the area of speech pathology or audiology, as the case may be, from an educational institution recognized by the board;
- (2) Submit to the board evidence of eligibility for meeting the requirements of the American Speech-Language-Hearing Association for the certificate of clinical competence in speech pathology or audiology, or both; and the evidence of eligibility shall verify that the applicant has completed:
- (1) A minimum of 375 hours of supervised clinical observation & clinical practicum with individuals who present a variety of communication disorders, which experience shall have been obtained within the applicant's training institution or in one of its cooperating programs; and (2) A clinical fellowship which shall have:
- (A) Begun after completion of academic coursework and clinical observation and clinical practicum;
- (B) Consisted of at least thirty-six weeks of full-time professional experience or its part-time equivalent
- **(C)** Been completed under the supervision of an individual who holds the certificate of clinical competence in the area of practice for which the certificate is sought, or board certification in audiology from the ABA for an audiologist applicant;
- **(D)** Consisted of primarily clinical activities; and
- (E) Required the supervisor to periodically conduct a formal evaluation of the applicant's progress in development of professional skills.
- (3) Pass a written examination approved by the board.

For audiologist applicants, at least thirty-six semester hours in professional coursework, which include;

- (A) At least thirty semester hours in courses for which graduate credit was received, twenty-one of which shall be in the area of audiology
- **(B)** At least thirty semester hours in audiology, at least six of which shall be in hearing disorders and hearing evaluation and at least six in habilitative or rehabilitative procedures, or both, with individuals who have hearing impairment;
- **(C)** At least six semester hours in speech pathology, at least three of which shall be in speech disorders and at least three in language disorders. This coursework in speech pathology shall concern the nature, prevention, evaluation, and treatment of speech and language disorders not associated with hearing impairment; and
- **(D)** A maximum of 6 academic semester hours associated with clinical practicum may be counted toward the minimum of 36 hours of professional coursework, but those hours may not be used to satisfy the minimum of 6 semester hours in hearing disorders and evaluation, 6 hours in habilitative or rehabilitative procedures, or both, or 6 hours in speech pathology

- (1) 30 hours or more per week over 9 months; (2) 25-29 hours per week over 12 months; (3) 20-24 hours per week over 15 months;
- (4) 15-19 hours per week over 18 months; (5) Less than 15 hours per week will not fulfill professional experience requirements;
- **(b)** Shall include direct client contact in at least 36 supervised activities, including but not limited to assessment/diagnosis/evaluation, evaluation, screening, habilitation/rehabilitation & activities related to client management as it pertains to the practice of speech-language pathology or audiology as defined in Section 3 of the Act;
- (1) At least 18 of the 36 activities shall be on-site observations by the supervisor. One hour equals one on-site observation; no more than 6 hours can be accrued in one day.
- (2) The other supervised activities may be accomplished through correspondence and include conferences, evaluation of written reports or evaluations by professional colleagues;
- (c) Shall be part of an evaluation and therapy program located in a school, clinic, hospital, community hospital or other equivalent settings
- (d) Shall be supervised by a licensed speech-language pathologist or licensed audiologist...
- **(e)** Shall begin after completion of the course work and clinical practicum education to meet the requirements for the master's or doctoral degree. In lieu of meeting the requirements set forth in subsections (a) through (d), the Division shall accept a CCC from ASHA or certification from the ABA that the applicant has completed the Clinical Fellowship required for certification as a SLP or audiologist.
- (4) The required fee as set forth in Section 1465.75 of this Part.

- (a) An application for a license as an audiologist shall be submitted to the board on a form provided by the licensing agency. An application shall be typed or printed in ink, signed under penalty of perjury, and accompanied by the following:
- (1) The fee required by section 5 of this rule.
- (2) An official transcript from an educational institution recognized by the board, certifying that the applicant possesses a doctoral degree or its equivalent as approved by the board from an accredited institution listed under section 1.5 of this rule in the area for which the applicant is applying for licensure. As used in this section, "equivalent" means having completed a minimum of 75 semester hours of graduate or professional study that includes academic course work in the following areas:
- (A) Fundamentals of communication. (B) Normal aspects and development of hearing and balance.
- (C) Clinical evaluation of hearing and balance disorders.
