### AAA 2022 + HearTECH Expo March 30-April 2, 2022 \*\* America's Center \*\* St. Louis, MO

As part of our commitment to your protection, health, and safety at AAA2022 + HearTECH Expo, all attendees, speakers, and exhibitors are required to provide proof of vaccination before checking in with us onsite. - AAA has adopted a "Vaccination Required" approach for all attendees, speakers, and exhibitors. A person is considered fully vaccinated if they meet the following criteria:
  - o 2 weeks after their second dose in a 2-dose series, such as Pfizer and Moderna vaccines, or
  - 2 weeks after a single dose vaccine, such as Johnson & Johnson vaccine.

If a person does not meet these requirements, they are not considered fully vaccinated and will not be permitted to enter the AAA 2022 Conference or receive a refund of any monies paid.

• AAA 2022 + HearTECH Expo will be using **Health Pass by CLEAR**, which provides a secure, digital proof of COVID-related health insights via the free CLEAR mobile app. Complete your health screening with **Health Pass by CLEAR** ahead of time for expedited check-in and entry!

# What do I need to do to provide my proof of vaccination to attend AAA 2022 + HearTech Expo?

There is a simple two-step process you must complete in advance for providing your proof of vaccination for AAA 2022.


Get ready for the event by downloading CLEAR for free on your mobile device or laptop and completing the one-time enrollment process to verify your entry requirements. Once your vaccination record has been uploaded to the platform, it can typically take up to 30 minutes for your status to be verified. When it is, a QR code will be generated and saved in your app. We encourage all attendees to complete this process as soon as possible but no later than at least one week before the event.

You'll be able to use Health Pass to confirm entry requirements before proceeding to St. Louis' America's Center.

# Step 1:

# Download and enroll in CLEAR

- 1. Download the CLEAR app and tap on the white Health Pass tile.
- 2. Tap "Enroll or verify in CLEAR" to create your CLEAR member account
  - a) **New to CLEAR?** When prompted, enter your email address, phone number, and have your government issued photo ID ready to complete enrollment.
  - b) Already a CLEAR member? Use the email address associated with your membership and take a quick selfie to verify your identity.
- 3. Continue to follow prompts on the Entry Requirements page to securely confirm your proof of vaccination.



## STEP 2 (complete ASAP):

Before arriving, complete your Health Pass on your smartphone for faster entry at our check-in desks located in Plaza Lobby on Level 1 of St. Louis' America's Center.

- 1. Open the CLEAR app and tap on the white Your Pass tile.
- 2. Select "Have a Code?" and enter the code EFATTENDEE416.
- 3. Confirm your identity with a quick selfie.
- 4. Complete the quick health survey.
- 5. Tap "Open Health Pass" to get your result. A green QR code means you're good to go!

<u>Disclaimer</u>: In accordance with HIPPA regulations, CLEAR will not share your specific data about your vaccination or test results with the event organization.

We will offer special consideration to those who cannot be vaccinated due to **qualifying medical conditions or disabilities**. If this is the case, these attendees will need to provide proof of a negative COVID test taken within 72 hours in advance of coming onsite. This information will be recorded in the Health Pass by CLEAR mobile app. Please email <u>aaainfo@audiology.org</u> to let us know if you fall into this category.

### What if I am an international delegate attending the conference and am traveling from outside the U.S.?

The CLEAR Health Pass app is not able to accept proof of vaccination for other vaccine types outside of Pfizer, Moderna or Johnson & Johnson. For international delegates, we will require that you present your vaccination card during your check-in process onsite as well as produce proof of a negative Covid-19 test taken within 24 hours of arrival into the U.S. Rapid Covid-19 tests are accepted but they must be performed by a verified lab. At-home rapid test will not be accepted.

### How will I receive my name badge and other AAA 2022 credentials?

Event staff will be present in Plaza Lobby on Level 1 of St. Louis' America's Center at a number of health screening stations. Guests will show the staff member their green AAA2022 CLEAR Health Pass screen on their phone or smart device.

Once cleared, registrants will be able to proceed to our registration counters located in Plaza Lobby on Level 1 of America's Center. Here, guests will scan their registration confirmation bar code that they received in advance via email and then show their photo ID to the staff member at the counter. Guests will then receive their AAA 2022 name badge, lanyard, and tote bag.

Once a registrant has received their AAA 2022 badge, they will have satisfied the Right of Entry requirements and will be able to move freely about the AAA 2022 meeting space and Expo Hall. Registrants will not have to show their green AAA2022 CLEAR Health Pass again. Guests should wear their name badge at all times and, in particular, as they enter the America's Center each day. If not, guests will have to go through the CLEAR Health Pass right of entry protocol again.

The AAA2022 CLEAR Health Pass will be offered in connection with CLEAR, an independent third party facilitating secure identity and vaccine validation via a free mobile application at airports, sports and entertainment venues, and other locations across the country.
