CH-EdAud Program Overview

The American Board of Audiology (ABA) offers the *Certificate Holder–Educational Audiology (CH-EdAud™)* training program to any licensed audiologist who wants to learn

- 1) Legislation and policies that inform audiology practices in the education setting;
- 2) Roles and responsibilities of educational audiologists;
- 3) Educationally relevant clinical and functional hearing assessment;
- 4) Classroom acoustics;
- 5) Auditory processing deficits;
- 6) Personal hearing instruments and RM technology;
- 7) Educational program considerations, IEPs, remote services, and advocacy;
- 8) Services for student wellness and habilitation; and
- 9) Practice management, including contracting and remote practice considerations

Participants do not need any previous knowledge of educational audiology practices, or to hold another ABA credential, to take this certificate program.

Program Description

The Certificate Program in Educational Audiology is a partnership between the Educational Audiology Association (EAA) and the American Board of Audiology (ABA). CH-EdAud is an online self-study program for audiologists that provides essential educationally relevant information for assessing and managing children and youth with auditory disorders in education settings. As an assessment-based certificate program, the CH-EdAud uses evidence-based instructional design principles to ensure efficient learning and retention of the information. It is an online self-study program providing lectures focused on key chapter content from *Educational Audiology Handbook* (4th ed, 2026).

The program aims to:

- a) bridge the gap between formal audiology graduate education and audiology practices unique to the educational setting;
- b) increase awareness among local and state education agencies regarding the roles and responsibilities of educational audiologists; and
- c) increase the number of audiologists with specialized training in educational audiology.

All ABA credentials are voluntary and independent. An audiologist does not need to be a member of any particular professional membership organization to obtain, or be eligible for, an ABA credential.

Eligibility

While other healthcare professionals can learn from the program, only licensed¹ audiologists (including those who become a licensed audiologist within the program subscription period) can earn the CH-EdAud credential.

To earn the CH-EdAud certificate, learners must

- 1) successfully complete, and pass the assessments of all seven education modules;
- 2) maintain current licensure;
- 3) submit appropriate training fees; and
- 4) agree to five *Affirmations*, which are included on the last page of this Handbook.

Scope

The CH-EdAud Certificate Training Program was developed to prepare audiologists to assess and manage children and youth with auditory deficits in educational settings.

Continuing Education Opportunity (CE)

Participants who successfully complete the CH-EdAud™ *Certificate Training Program* will earn 1.95 Tier 1 CEUs. Completion of individual modules will earn 0.25-0.3 Tier 1 CEUs.

Program Format

The CH-EdAud certificate program includes seven (7) modules that must be completed to earn 1.95 Tier 1 CEUs. When completed within twelve (12) months from the initial registration date and verification of licensure or other relevant audiology credential, ABA will award the CH-EdAud certificate. The course is derived from the chapter content of the *Educational Audiology Handbook* (4th Edition, 2026), which is required to complete the Modules. It can be purchased at www.edaud.org where EAA members receive a 25% discount (member login required). Following completion of Module 1, participants can complete the remaining modules in any order.

- **Module 1-Foundational Information and Practice:** Identifies pertinent laws and regulations that impact the practice of audiology in educational settings, historical information and data, and describes the roles and responsibilities of educational audiologists. (0.25 CEU)
- **Module 2 –Assessment:** Describes procedures for hearing screening and educationally relevant audiological assessment including classroom acoustics. (0.3 CEU)
- **Module 3 – Educational Program Considerations, Individual Education Plans, and Advocacy:** Identifies pertinent components of educational programs for deaf and hard of hearing students and advocacy methods for addressing them. (0.3 CEU)

¹ Licensed refers to state regulatory agency, state education agency, or other state agency that requires a license to practice as an audiologist.

- **Module 4- Auditory Processing Deficits:** Describes APD from an educational perspective and procedures for assessing APD. (0.25 CEU)
- **Module 5 – Hearing Instruments and Remote Microphone Technology:** Reviews personal and remote microphone hearing access technology including use, benefits, and limitations as used by children in educational settings, protocols for considering appropriate options for individual children, and management strategies for schools to ensure ongoing and consistent access. (0.25 CEU)
- **Module 6 – Student Support and Family Partnership:** Identifies relevant habilitation practices and parent support methods that are used in the educational setting to support language acquisition and hearing and listening development. (0.3 CEU)
- **Module 7 – Service Delivery Considerations, Program Development and Evaluation, Future Directions:** Describes remote service delivery considerations, educational audiology services provided by contract, and procedures for developing, managing, and evaluation services. (0.3 CEU)

Training Sequence

The participant is required to complete all seven modules to earn the CH-EdAud credential. Module 1 must be completed first with the remaining modules completed in any order. The length of recorded lectures for each module varies from about ninety minutes to two hours. Including chapter readings and the review of tools and resources, participants should expect to spend up to three hours per module.

Training Window

The purchaser of the program has a 12-month subscription to complete the program to earn the certificate. After completing Module 1, the participant may navigate forward and backwards through the modules to review content. After the 12-month period, the subscription to the program closes and the user will no longer be able to access the online modules.

Assessments

Each training module includes a “knowledge check”, or assessment, to determine if the participant has met the learning objectives and learning of the materials. The assessment includes a set of single answer, multiple-choice test questions for each module of training. Assessments remain open until passed, allowing the learner to go back to review materials and test again.

Each assessment is tightly linked to, and designed around, the education program’s learning objectives and content of the *Educational Audiology Handbook*. Learners must pass all seven education module assessments to earn the CH-EdAud certificate.

Additional Training Resources

Each module includes several resources beyond the online training. These include forms, assessment tools, and management resources located in the Appendixes of each chapter of

Educational Audiology Handbook. Throughout the course, there are links to various publications and websites for further reading.

The CH-EdAud Certificate

Participants who complete the education program and pass all assessments within the 12-month training window will earn the *Certificate Holder—Educational Audiologist* certificate.

The recipient of this credential may use the term “Certificate Holder—Educational Audiologist” and may use the acronym “CH-EdAud” similar to degrees and other professional credentials (e.g., S Smith, AuD, CH-EdAud).

Certificate Validity

The CH-EdAud Certificate provides essential knowledge and skills to prepare audiologists to work effectively in the school environment. The certificate does not expire, and there is no renewal requirement.

Training Fees and Registration

CH-EdAud training modules are offered through the online on-demand continuing education source of the American Academy of Audiology (AAA). A discounted registration fee is available to members of AAA and EAA, and those who hold ABA certifications. Any non-AAA member eligible for the discount should contact aba@audiology.org to receive a coupon code prior to registration. Invoicing is also available for group registrations; please contact aba@audiology.org for details.

Program Development/History

In building the CH-EdAud Certificate Program, the ABA aligned the development of the training program to *ASTM E2659-15 Standard Practice for Certificate Programs*. ASTM International is one of the largest voluntary standards developing organizations in the world. Training and assessments are tightly linked, and designed around the training program’s learning objectives.

ASTM Development Standards provide guidelines for quality program development and administration; distinguishes qualified workers with industry-recognized credentials; differentiates certificate programs from non-assessment-based programs that award “certificates of attendance” or “certificates of participation”.

EAA has had an interest in developing a specialty certification/certificate program since the first membership survey was conducted in 2001. While supported by members, the EAA Board at the time determined that the organization and its membership did not have the financial capacity to support a certification program. However, EAA members continued to discuss the benefits of a certification/certificate program. Based on a 2021-22 survey of AuD programs that found limited educational audiology coursework within AuD programs, EAA formed a specialty certification committee in 2022 to explore membership commitment once again. Based on the high level of interest found in the 2023 survey, the committee proceeded with developing a certificate program model. During this process, EAA learned more about the ABA Certificate programs and found the model aligned with the EAA committee’s priorities. Partnership discussions began in the fall of 2024. Working through an established program relieved EAA of the costly delivery and management aspects of a certificate program. The AAA, ABA, and EAA reached an agreement in the spring of 2025 for ABA to host and manage the program while EAA provided the content and instructional videos. The program went online in August 2025.

The CH-EdAud program is designed for the active learner. The modules take advantage of e-learning features that group together materials in logical fashion, using sound instructional design principles to reinforce learning and retention. The online design accommodates different learner styles and allows the participant to set his or her own pace for completion.

Statement of Principles and Affirmations

The *Assessment-Based Certificate Holders Code of Ethics* of the American Board of Audiology specifies professional standards that provide for the proper discharge of audiologists' responsibilities to those served and protects the integrity of the profession.
