



Presenter Agreement

All presenters must agree to the terms of the Presenter Agreement prior to entering an abstract/proposal. The Presenter Agreement reads as follows:

On behalf of myself and any co-presenters, should this presentation be selected, I/we agree that this presentation is offered voluntarily and understand and agree to the following terms related to the presentation and its use by the American Academy of Audiology:

- **I agree to pay for all travel expenses to attend AAA 2026 Annual Convention including the registration fee.**
- **I agree to present the approved session on the assigned date, time, and place onsite in San Antonio at AAA 2026 Annual Convention. I understand my session will be scheduled at the discretion of the Academy.**
- **If presenting a poster, I agree to be onsite to present the approved poster in the poster hall on Thursday, April 23 and Friday, April 24 during designated poster display/presentation hours.**
- If applicable, I agree to record a presentation for a virtual convention offering if requested unless notification is sent to the Academy.
- During my presentation, I will not engage in any type of promotional marketing or selling of any product or service.
- I warrant that my presentation is my own original work, I have the full authority to enter into this agreement, and I am the copyright holder, or I have obtained all necessary permissions or licenses from any individuals or organizations whose material is included or used in my presentation.
- I agree to avoid any claims or misrepresentations and will NOT hold the Academy liable for those in my presentation.
- Unless otherwise specified in writing, I grant the American Academy of Audiology all necessary rights to record this presentation and to use it in digital format to further educate and inform attendees and the audiology/hearing healthcare community.
- To the best of my knowledge, my presentation and/or poster does not/will not violate any proprietary or personal rights of others (including any copyright, trademark, and privacy rights), is/will be factually accurate, and contains nothing defamatory or otherwise unlawful.
