Exhibits/Sponsorship & Promotion Policy

*as of June 2025

Sponsorship & Promotion refers to all Academy event exhibitor and/or sponsor print, branding, educational and electronic communication.

All AAA Annual Convention promotion via exhibiting and/or sponsorship is subject to approval by the American Academy of Audiology (Academy). The Academy reserves the right to accept only that sponsorship & promotion that meets our standards. These standards include, but are not limited to the following:

- 1. Products or services eligible for promotion should be relevant and of value to the science and daily practice of audiology and its related disciplines.
- 2. All devices classified by the U.S. Food and Drug Administration (FDA) as a medical device or product must adhere to the regulations provided by that agency.*
- 3. If requested by the Academy, all exhibitors/sponsors must show proof of product efficacy for promotional claims made. This may include clinical trial data and/or publications and should be easily accessible via a website or other means.
- 4. Any promotional content in conflict with the Academy's Code of Ethics and/or any of the Academy's related ethical practice guidelines will not be accepted.
- Literature of other promotional materials included as part of the sponsor benefits package will be reviewed by the Academy for claims, including sponsored convention and all-member eblasts.
- 6. Statements about and illustrations of all products must meet professional standards and must not be deceptive or misleading by either statement or omission, must not disparage others in any way or reflected any unsupported claims.
- 7. Promoting products and services deemed to be in direct competition with the Academy's or Academy Foundation's products and services ordinarily will not be accepted unless otherwise approved by the Board of Directors.
- 8. The Academy reserves the right to refuse, reject or cancel and promotion or sponsorship element for any reason at any time without liability, even though previously acknowledged or accepted.
- 9. The Academy and Foundation will publish the following disclaimer on all publications and exhibit/sponsorship contracts respectively:

"Publication of an article, or advertisement, in any Academy publication does not constitute a guarantee or endorsement of the quality, safety, or effectiveness of any products or services described therein or of any of the representations or claims made by the author(s) or manufacturer(s) with respect to such products or services. The Academy is not responsible for any claims made. The exhibitor/sponsor will be responsible for ensuring all products comply with all applicable federal and state laws, and they must meet applicable FDA regulations and FTC requirements. Adherence to legal and regulatory requirements concerning the promotion of any product or service is the exhibitor's/sponsor's responsibility"

Companies in violation will be subject to the penalty as listed in the Enforcement of Rules and be applied to Priority Point space selection."

- As of June 2025, AAA Annual Convention <YEAR> (formerly AAA <YEAR> + HearTECH Expo) is the official name of our convention and should be referenced as "AAA Annual Convention [4 digit YEAR]."
- Exhibitors and/or sponsors may use the "AAA Annual Convention [4 digit YEAR]" name in their creative and/or the "AAA Annual Convention [4 digit YEAR]" Exhibitor logo, supplied by the Academy.
- The American Academy of Audiology must be referenced in full name first and then can be thereafter abbreviated as "the Academy".
